Superintendent Weninger reported that 1) a reaffirmation of the partnership with the Village regarding the use of OPRFHS facilities in the event of a village-wide emergency would occur would be brought the Board of Education in May; 2) the Boosters Dinner/Dance/Auction is scheduled for Saturday, May 1; 3) OPRFHS will host both the River Forest Council of Governments meeting and the Oak Park Council of Governments meeting in the month of May; 4) the status of the "Race to the Top" Program; and 5) the 19<sup>th</sup> Century Club Annual Scholarship luncheon will be held Monday May 3 and five scholarships will be awarded to OPRFHS female students.

A Public Hearing on the Amended Budget was held.
