- dropped residency student RES 09/22/05-01 from the rolls of Oak Park and River Forest High School as of September 22, 2005, due to nonresidency and will charge for tuition accrued in the amount of \$1436; dropped residency student RES 09/22/05-02 from the rolls of Oak Park and River Forest High School as of September 22, 2005, due to nonresidency and will charge for tuition accrued in the amount of \$1436; dropped residency student RES 09/22/05-03 from the rolls of Oak Park and River Forest High School as of September 22, 2005, due to nonresidency and will charge for tuition accrued in the amount of \$27,332.76; dropped residency student RES 09/22/05-04 from the rolls of Oak Park and River Forest High School as of September 22, 2005, due to nonresidency and will charge for tuition accrued in the amount of \$25,896.76.
