Actions**

The Board of Education approved the following consent items: • Resolutions Ratifying Expenses • Resolution Authorizing Execution of Certain Vouchers for the month of July • Check Disbursements and Financial Resolutions dated September 24, 2009 • July 2009 Treasurer's Report;

- approved payment of curricular development time for Devon Alexander;
- certified the mid-summer graduates of 2009;
- amended Policy 1320, School Visitors;
- amended Policy 6160, Academic Honesty, as presented at the PEG Committee;
- approved Policy 3030, Athletic Field(s) and Stadium Lights, for First Reading;
- approved the Resolution declaring the intention to avail of the provisions of Article 20 of the School Code of the State of Illinois, as amended, and to issue Working Cash Fund Bonds of Consolidated High School District Number 200, Cook County, Illinois, and directing that notice of such intention be published in the manner provided by the law;
- approved the Resolution amending the resolution providing for the issue of not to exceed \$12,000,000 General Obligation Limited Tax Refunding School Bonds, Series 2009, of Consolidated High School District Number 200, Cook County, Illinois;
