Some students and the faculty supported the move, nothing that it would be easier for parents and staff to attend following the school day. Discussion ensued about being consistent and whether moving graduation permanently to Thursday should be a Board of Education discussion. A suggestion was to begin graduation at 6:00 p.m. so that it would end before dark and families would still have time to go out for dinner. Consideration had been given to holding graduation on Sunday, June 5, 2016 but that conflicted with the A Day in Our Village. It was the consensus of the Board of Education members to add this as a discussion item to its regular August Board of Education meeting. Continued

discussion will occur about permanently moving graduation to Thursdays. A suggestion was also made to stream graduation live so that that extended family and friends could witness the event.
