

**AMENDMENT TO ADMINISTRATIVE CONTRACT**  
**ASSISTANT ADMINISTRATOR FOR CURRICULUM AND INSTRUCTION**

**AGREEMENT** made this \_\_\_\_ day of June, 2017 between the **BOARD OF EDUCATION OF OAK PARK AND RIVER FOREST HIGH SCHOOL DISTRICT 200** (the "District"), COOK COUNTY, ILLINOIS (the "Board"), and **PHILIP PRALE** (the "Administrator").

**WITNESSETH**

**WHEREAS**, the Administrator is currently employed under a multi-year employment contract extending until June 30, 2017 (the "Contract");

**WHEREAS**, the Board and the Administrator have agreed to modify the terms of the Contract by written amendment; and

**WHEREAS**, the Board has found that the Performance Goals set forth in Paragraph 4 of the Contract are being met.

**NOW, THEREFORE**, the Board and the Administrator agree to amend the Administrator's Contract as follows:

1. Paragraph 1 of the Contract shall be amended by modifying the termination date of June 30, 2017 to July 31, 2017.
2. The second sentence in Paragraph 1 of the Contract shall be amended to read as follows:

The parties acknowledge that the Administrator has submitted his irrevocable notice of resignation and will retire at the conclusion of this Agreement.

3. The Contract shall be amended to include a second paragraph as a part of paragraph 2:

For services rendered between July 1, 2017 and July 31, 2017, the Board agrees to compensate the Administrator based on the District's summer teacher rate, subject to such deductions as are required by law and as may be agreed upon by the Administrator and the Board. In addition to this base salary, the Board shall continue to pick up and pay on behalf of the Administrator 5% of his required employee contribution to TRS pursuant to the terms as set forth in Paragraph 2 of this Agreement. During this time, from July 1, 2017 through July 31, 2017, the Administrator shall be responsible for credit recovery, closing out of

summer school, and transitioning new personnel, among other duties to be assigned by the Superintendent. All other benefits as set forth in this Agreement shall remain unchanged.

4. All other terms and conditions of the Administrator's Employment Contract will remain in full force and effect through the amended termination date of July 31, 2017.
